### FROM THE PRESIDENT

t has been a very busy year for me and the Kensington Downs Board. We managed to complete many new (and some old) projects. This will serve to update homeowners on what has transpired so far this year and plans for the balance 2012 and into 2013. I'm sure you will recall the cement leveling done on the common area sidewalks and repairs to ruts in the shallow/ditch common area behind homes on Red Clover Lane.

Flag markers were purchased and installed for wintertime identification of our fire hydrants.

During the Community Clean-Up Day in April, we planted four new trees, cut down one tree and pulled weeds/pruned foliage at the entrance, and trimmed trees along Maysville and Welshire.

We have purchased a new sign for the entrance, which will be installed very soon and three dead trees along Maysville Road have been removed.

The Board hired an attorney to review our existing bylaws and we are in the process of discussing and implementing his recommendations.

The one existing fountain at the pond finally "bit the dust" in April, and the Board purchased one, new fountain at one-fifth the cost of the old fountain. It uses less electricity but still has the same spray pattern (height and diameter) as the old fountain.

During this Spring-Summer, we've experienced some of the hottest and driest weather on record. Thank goodness for the recent rainfalls. Yet, the Board needed to take extra precautions since drought conditions still persist. We have instructed Martin Lawn Service to give extra attention to weed control and Pond Champs has been making weekly visits to assess the pond and apply extra algae treatment when needed. I'm sure that this wacky weather

has adversely affected your lawns as well. Spot-treating the weeds and watering grass occasionally is your best bet to keep from having to re-seed your yard. The wind storm on June 29th destroyed four trees along Welshire Blvd.

We have removed the one in the common area, but the other three trees were on the park-strip (City of Ft. Wayne is responsible).

City workers recently removed one tree which they considered to be a "hazard", but they said that the two damaged trees at the entrance will have to wait (sometime in September is on their schedule). So, the board decided to have these trees remove ASAP. We hope to replant trees this fall or early next spring, with consideration to availability and price.

The pond sign was also blown down by the wind storm, and we have already purchased new ones that will be installed very soon.

Board projects planned for 2013 include a 3-foot expansion of the Welshire shed to accommodate storage of equipment (salt barrels, signs, etc.) in one location.

#### OTHER PROJECTS:

ADA ramps for the common area sidewalks, updated copies of the directory and bylaws for distribution to all homeowners, a new landscaping plan for the entrance, and rust removal/fresh paint for all the community mailboxes. The Board welcomes your suggestions, and invites all homeowners to attend and participate in the upcoming ANNUAL MEETING on Thursday, November 8, 2012.

Kensington Downs Homeowner Survey Results are In!

The homeowner survey (mailed with the annual dues statement) was completed and returned by 126 homeowners (54% return rate). The vast majority of respondents (94%) were in favor of continuing the new procedure of mailing the agenda, financial report and an absentee ballot to all homeowners prior to the annual meeting. A full 90% of respondents were in favor of continuing the use of an absentee ballot. With regard to the installation of a sidewalk for access to the KD pond, only 38% of the respondents thought

this was a good idea, and there was no clear consensus as to exactly where the sidewalk should be located. As for fountain use at the pond, only 32% of the respondents were in favor of purchasing a new unit to replace the broken one, while 73% felt that we should continue to use just the one remaining/working fountain during the 2012 season. ### Reduce, Reuse, Recycle. You CAN Do It!

We can all help to keep the cost of trash collection down by recycling more and putting less in the garbage. Since the one-cart recycling program started in January 2011, the percentage of Fort Wayne households that recycle has grown from 33% to almost 73%. Recycling also provides a direct financial benefit to the City of Fort Wayne (estimated to top \$500,000 annually). Therefore, City officials have been able to pass this along to all residents in the form of lower monthly fees for trash collection.

Recycling is easy to do. There is no need to separate your items - everything goes into one container.

(A "Recycling Cart Do's and Don'ts"

placard comes with this newsletter.) Recycling pick-up is provided by the City at no extra cost. You can start now - just call 311 to request a recycling cart. You have a choice of either the large (96-gallon) cart or the smaller, 48-gallon cart.
