

### FROM THE BOARD

fter those two, big snowstorms in March, let's hope that the nice springtime weather is finally here to stay! As the weather gets warmer, homeowners will be leaving more doors and windows open; so this is a good time to remind everyone that break-ins can be prevented if we all pay some extra attention. Although Kensington Downs is generally a safe neighborhood, we have had some problems lately. On one evening in early February, there were five incidents of vandalism and theft from cars at three separate locations on White Plains Court and one each on Derby Lane and Scarlet Court. On March 17, a theft was reported on Kerrigan's Way; and most recently (March 28) on Bent Willow Drive, items were stolen from the cars parked inside a closed garage that was breached through an unsecured, service door. Remember to lock your vehicles and keep all valuables out of sight or remove them completely, keep those garage doors down, and please secure your garage door openers. Don't provide any easy targets. All homeowners are encouraged to stay alert to your surroundings, report any suspicious activity, and keep more of your outside lights burning during the evenings and nights.

The Board has hired a new vendor for lawn maintenance this season (Hoosier Land Care), and you can expect to see them mowing all of the KDCA property on Fridays. This vendor will mow all of the common area surrounding the detention pond too. We make the following request of all homeowners on the pond: when applying fertilizer to your property, please do not extend the application beyond your lot line and into the common area. If we can reduce fertilizer runoff into the pond, the potential for creating algal blooms will be greatly diminished. Thanks for your cooperation.

There is one final item and this concerns those March snowfalls. If the snowplow dislodged some of your lawn sod during the snow removal process, please report the matter to us so we can bring it to the attention of the vendor and arrange for any needed repairs. As always, we encourage all homeowners to communicate directly with any member of the KDCA Board of Directors regarding your concerns, questions and suggestions.

# Happy 25th Anniversary, KDCA

ensington Downs Community Association, Inc. (KDCA) was established as a not-for-profit corporation in the State of Indiana on February 2, 1988; and our homeowner association is still going strong after 25 years!

The primary purpose of any homeowner association (HOA) is to maintain and enhance property values through enforcement of the covenants and maintenance of the common areas. The developer typically creates the HOA during the early phases of building in the subdivision, and each homeowner automatically becomes a member of the HOA when they purchase their home. Colonial Development Corporation (Roger, Herbert and Larry Delagrange) began building Kensington Downs (KD) in 1987 with construction of the villaminiums and the homes along Welshire Blvd., Bent Willow Drive and Oxford Court. Building in our subdivision continued over the next 7-8 years, until the last home lots were completed along Greymoor Drive, Brimfield Court and Scarlet Court.

KDCA is governed by a Board of Directors, which initially was the developer (Colonial) and its representatives; but control transitioned completely to the homeowner-members of KDCA by December 31, 1994. Since January 1995, the KDCA Board of Directors has been populated solely by KD homeowners, who have been elected by the KD residents.

While the Association's various governing documents are very important in defining the community standards for the purpose of protecting property values, it is the job of the Board of Directors to uphold these restrictive covenants, bylaws, architectural guidelines, rules and regulations while also seeing to the day-to-day affairs of KDCA. Clearly, a strong and committed Board of Directors is critical, and the willingness of KD homeowners to serve on that Board is essential. Let's keep KDCA going strong for the next 25 years and beyond - please consider serving on the KDCA Board of Directors.

Call 311 to report broken street lights, potholes that need filling, trees down in the park-strip, and cars parked on the street for extended periods of time.


