The Neighborhood Pond

Each season the Board of Directors of Kensington Downs receives questions and concerns from members of the neighborhood association, especially those homeowners bordering the neighborhood pond. I have read three articles and gleaned some pertinent information that will be beneficial to maintaining clean water in a more environmentally friendly fashion. Two of the articles were written by Ricky Kemery, The Plant Medic, who is the extension educator for horticulture at the Allen County branch of the Purdue Extension Service. Another article was offered by Pond Champs (the company employed by KDCA to handle our annual "clean water" contract needs at the KD retention pond).

The main purpose of retention ponds installed in this and other subdivisions is to mitigate water runoff - giving the water a place to go - instead of running directly into storm drains and sewers. Many retention ponds are shallow compared to small lakes or ponds designed for fishing and recreation. A natural pond has vegetation in and around the pond that will help keep the water

clean. Many associations want a pond devoid of vegetation and also want fish. Healthy fish need cover to flourish.

Countless retention ponds are surrounded by acres of turf, "fed" each year from neighborhood lawns with quick-release high nitrogen and phosphorous fertilizer, which can contribute to weed and algae growth. The following are some suggestions for a more sustainable retention pond.

Use slow release fertilizers in the spring. Avoid applying fertilizer right before raging thunderstorms, and avoid applying fertilizers within 15-20 feet of the pond. Use a low or nophosphorous fertilizer (Pond Champs recommends that the

middle number of the analysis should read 0, i.e. 30-0-15).

Pond Champs also says that you should mow clippings away from the pond and only mow to about 15 feet of the pond's edge.

Pond Champs states that around the pond grass be allowed to grow a little taller. This grass is considered common area and is maintained by our lawn service.

And, finally, Mr. Kemery suggests the KDCA might want to consider establishing some desired aquatic vegetation in and around the pond. This vegetation will help filter, capture, and clean the water entering the pond.

To maintain cleaner water in a more environmentally friendly fashion we need to consider these suggestions to improve our neighborhood pond. We have already taken steps to a better pond by placing riprap around the perimeter of the pond and have a fountain to increase air and add disruption to the surface of the water, making it harder for algae mats to form. Let's all be more aware of these easy fixes so our pond has cleaner water and requires fewer inputs, and less money, to maintain.

The City of Fort Wayne will be resurfacing Welshire Boulevard and Asher Drive this summer. Please be aware of this construction and plan accordingly.
