Maintenance Concerns

The utility posts that are located along the rear property-line of each Kensington Downs home lot, contain the connections for services such as your cable TV, internet and telephone. Recently, several residents have contacted KDCA Board members to voice their concerns about the state of "disrepair" of these utility posts (e.g., wires are exposed, posts are tipped over). Since these utility posts are not the property of the Association, the Board directs all concerned residents to contact the specific utility company to request any needed repairs. The necessary identifying information should be labelled on the post. Maintaining your utility posts will help to keep you connected!

Some residents have commented about the "mulching of trees along Welshire Blvd. and at the KD entrance", so a quick update is in order. On advice from the City Arborist (Chad Tinkel), grass will be installed around the larger trees along Welshire Blvd. The smaller trees at the KD entrance, as well as any newly-planted trees along Welshire Blvd., will continue to have a mulch ring installed around the tree trunk. The work will be done by our lawn maintenance vendor (Hoosier Land Care), with the grass planting occurring this Fall. Activities will require close coordination with the City of Fort Wayne, who will be planting a few more trees at the KD entrance, along Welshire Blvd. and Maysville Road during October/November 2014.

Homeowner Survey Results

The 2014 homeowner survey, which was mailed with the annual dues statement, was completed and returned by 108 homeowners (i.e., a 46% return rate). Homeowners were given eight (8) different items and then asked to rate the "importance" of each item using a 4-point scale. The survey findings are summarized as follows. [If you are interested in the "number crunching" specifics, please see the final report posted at the KD website.]

More than 50% of the responding homeowners had no interest whatsoever in participating in a holiday lighting contest or a summer landscaping contest. Furthermore, an additional 30% of the homeowners rated both of these activities as only "minimally important". With regard to block parties and other social events, a full two-thirds of the survey respondents expressed "very little interest to no interest" in these types of events.

The establishment of a Neighborhood Watch Program was very important/somewhat important to two-thirds of the homeowners responding to the survey. When asked about additional lighting along the common area sidewalks, approximately two-thirds of the respondents also rated this as very important/somewhat important. In contrast, the planting of more trees in the KDCA common areas was rated as very important/somewhat important by only one-third of the survey respondents.

The item regarding support for the Lake Forest Pool and Swim Club evoked a strong response, with almost equal numbers of advocates and detractors being identified. However, this matter is now a moot point, because Lake Forest has opted for permanent closure of their swimming pool.

The installation of more street light poles within our community was rated as "very important" by the highest percentage of respondents (39%). The KDCA Board of Directors has already begun working with the City of Fort Wayne to accomplish this goal.

Posting Signs at the Entrance By KDCA Board of Directors

Are you a homeowner who wants to post a sign at the Kensington Downs entrance to advertise an event (e.g., your garage sale, a birthday party, a baby shower) or that your house is "For Sale by Owner"? Then, please be advised of the Association rules that need to be followed. The applicable rules are clearly stated in the KDCA Bylaws (Article VII,

(1) Homeowners can place "well presented signs" in the Common Areas of the Association on Fridays, Saturdays and Sundays ONLY.

Sections 3 & 3a).

- (2) The individual who placed the sign in the Common Area is responsible for removing the sign by Sunday evening.
- (3) For a sign to be placed in the Common Area at ANY OTHER TIMES, written permission from the KDCA Board of Directors is required.

Of course, all City of Fort Wayne ordinances and regulations will also apply (e.g., limitations on sign size). Since we are beginning to see
