- The youth will be in our subdivision to paint numbers on June 4, unless other arrangements are made with Tommy Moll.

The KDCA irrigation system is being serviced again this year by Pfister ■ Sprinkler Systems.

Villa resident Larry Porter, and KDCA Board members Cary Baron and Tom Eggold met with the Pfister personnel on April 14, and the sprinklers should be operational now.

Please be aware that the City of Fort Wayne will be installing several ADA ramps in The Villas. Also, the City will be installing a new street light pole at the corner of Derby Lane and Preakness Cove. Both of these projects will commence sometime this year. Many thanks to KDCA Board members Tom Eggold and Arlene Klapes for working with the City to make this happen.

Please see the list to the immediate left for the names of individuals who have agreed to serve on the Villas Board for 2016. The Grounds Committee responsibilities for each person are also listed. In addition, Tom Eggold, Lyn Schlegel and Tom Watt serve on the KDCA Board of Directors as the District 2 (The Villas) representatives.

# 2016 Projects By KDCA Board of Directors

**7** our KDCA Board of Directors ■ has been very busy working to maintain the standards that have made Kensington Downs one of the nicest neighborhoods in Fort Wayne. The following projects will proceed during 2016:

- 1) All street sign posts (17) in Kensington Downs will be power washed and painted (shamrock green with white lettering). In addition, nine (9) sign posts will be repaired prior to painting.
- 2) Traffic Calming Measures on Welshire Blvd. & Kerrigan's Way (see newsletter article)
- 3) Street/House Number Painting on Curbs (see newsletter article)
- 4) The Fort Wayne Department of Public Works will be installing ADA ramps at the following intersections: Welshire Blvd. & Bent Willow Drive, Scarlet Court & Algate Lane, and Kerrigan's Way & Red Clover Lane. In addition, ADA ramps will be installed at every street entry/sidewalk

- curb cut location in The Villas where a ramp does not exist presently.
- 5) After consulting with Herb Berg (Fort Wayne Street Light Engineering Dept.), we learned that only one (1) area in Kensington Downs does not meet the City's minimum lighting standard (i.e., intersection of Derby Lane & Preakness Cove). The City will be installing a new street light pole on this corner.
- 6) The poor drainage of storm water (flowing west to east) in the common area between Weeping Willow Court and Red Clover Lane has been a longstanding issue. A plan to improve the swale and ensure proper drainage is being devised.

Bridge construction over Bullerman Drain (Ditch) is complete, and we can once again access Maysville Road to the north. In the December newsletter, we presented the Board's concerns about the deteriorating condition of the Ditch, and we proposed a letter writing campaign to get Allen County officials to focus efforts on improving the integrity of this vital storm water drain.

Bullerman Drain is an important piece of our community infrastructure, and the time has come for us to "encourage" the County to do its part in maintaining the Ditch. We are asking KDCA members to contact each of the three (3) Allen County officials listed to the right. Be Bold - call them, email them, send "snail mail"! # **Traffic Calming Measures**

Over the past several years, we have received an increasing number of reports of motorists speeding on Welshire Blvd. and Kerrigan's Way. Since this is a major risk to the safety of pedestrians and bicyclists, the Directors are seeking to apply some traffic calming measures on these two (2) streets.

The KDCA Board requested that a traffic study be conducted

by the City of Fort Wayne, and that study was carried out by Traffic Engineering Department officials on March 22-25, 2016. The results were alarming!

The daily traffic flow on Kerrigan's Way (at the intersection of Red Clover Lane) exceeded 900 vehicles per day with an average speed of 31 mph (targeted range of 24-33 mph). The daily traffic flow on Welshire Blvd. (at the intersection of Bent Willow Drive) exceeded 1500 vehicles per day with an average speed of 33 mph (targeted range of 25-34 mph).

The City considers any daily traffic count exceeding 600 vehicles per day to

be a legitimate reason for requesting traffic calming measures. Therefore, the KDCA Board of Directors, in consultation with City officials, has approved the following recommendations:

(1) Due to the excessive speed of many motorists who travel on Welshire Blvd. from Maysville Road (at the KDCA main entrance) to Kerrigan's Way, and on Kerrigan's Way between Welshire Blvd. and Tipperary Trail, it is recommended that three-way stop signs be installed at each of the following two (2) intersections: (a) Welshire Blvd. and Bent Willow Drive, and (b) Kerrigan's Way

and Red Clover Lane.

(2) We request a change in the posted speed from 30 mph to 25 mph on Welshire Blvd. and Kerrigan's Way.

We expect that this reduction in the posted speed will add to the other traffic calming measures (i.e., the posting of 3-way stop signs) that KDCA has already requested of the City of Fort Wayne.

Before the City's Traffic Engineering Department can install these signs, 75% of the residents in KDCA must approve the actions as listed on the official petition. During the month of May, several of our community residents will be distributing

the petition and asking for your signature. If you have any questions about the proposed changes, please email KDCA Board member Tom Eggold at eggoldte@gmail.com.
