The following are the minutes from the special meeting.

Kensington Downs Community Association Special Membership Meeting February 22, 2006

A special meeting of the membership was held in response to a petition filed by 53 homeowners. The agenda of the meeting included: a vote for the removal of the board of directors and, if the petitioner's prevailed, the election of new directors.

At 7:30 p.m., at the Lahmeyer Road fire station, President John McGauley called the meeting to order. A motion was made by homeowner, Nancy Louraine, to remove the board of directors. A second was made by homeowner, Bill Blue. Discussion followed until 8:15 p.m.

The voting process concluded at 8:30 p.m. The current board of directors left the room, three Fort Wayne firefighters volunteered to read the votes cast and record them on the wall board. Renee Bloom, counsel retained by the Association, reviewed the proxy ballots for accuracy before they were recorded.

The results of the voting are as follows: 162 votes cast—81 to remove the board; 80 to retain the board and one proxy vote that was ruled invalid because the date was incorrect. Upon hearing the final vote count, the board resigned and left the building.

There were 45 homeowners remaining in the room. Steve Elmer, homeowner, was unanimously appointed to chair the remainder of the membership meeting for the purpose of electing new directors.

To try and insure that all sections of the association would be represented by the board a motion was made that no more than 2 members from each section be elected to the board at this meeting. The motion was seconded and passed by the homeowners.
