Neighborhood Pride Fights Crime by Joe Squadrito

Have you ever read the weekly crime statistics published in the Fort Wayne Sunday Newspaper? They report the types of crimes and the associated geographic areas or districts. Kensington Downs is in District 23, which encompasses most all of the Georgetown area of our city. There are seven (7) types of crimes that are reported, and each month the police prepare a report to United States Justice Department called the Uniform Crime Report or UCR for short. Burglary and theft are just two (2) of the categories reported; and with few exceptions, our district seems to be victimized regularly. Although we live in District 23, Kensington Downs has reported no burglaries or thefts, while sub-divisions that neighbor ours have had what I consider to be ever increasing numbers. While there are several reasons for this, the principal reason is our strong sense of possession and pride in ownership. It's a fact that well-maintained homes and properties are less likely to experience property crimes then those in need of upkeep.

As the holidays approach, parcels will be placed in our vehicles in plain view. Leaving parcels, laptops, GPS equipment and other valuables in plain view is an invitation to victimization. Letting newspapers stack up on the driveway or at the door is an invitation to burglary. An empty trash container (lid open) left at the curb overnight is another indication that the homeowner is away. Empty boxes and other packaging, especially those for electronics, left at the curb for recycling are another invitation to burglary, as electronics are easily sold on the black market. Cut that cardboard packaging up and then place the pieces into the recycling bin, or take the boxes to the recycling center on Pontiac Street.

Know your neighbors, their children and their schedules. If something looks out of place, call law enforcement. Do not try to investigate the matter yourself. Today's criminals are usually substance abusers seeking to support their addiction, and there's no telling how they will react to detection. Let your neighbor(s) know when you'll be away for prolonged periods. Finally, if you have elderly neighbors or neighbors who are ill or disabled, check on them, especially if they live alone. These are just a few tips that I hope will keep Kensington Downs a good, safe place to live.

Annual Meeting Highlights by Arlene Klapes

Atotal of 38 homeowners attended the KDCA Annual Meeting on November 8, 2012. Thirty (30) KD lots were represented. Again this year, all homeowners received annual meeting materials (by mail) prior to the meeting, including an official ballot and a financial report. Eighty-three (83) valid ballots were submitted, which is an increase over the 74 ballots submitted in 2011.

The 2013 budget (totaling \$29,372) was approved. Three homeowners (Tom Eggold, Carol Griffin, and Dave Pennell) were elected to the KDCA Board of Directors. Three Directors had terms expiring (Tim Bastress, Dave Ritenour, and Bill Stiles), and one Director "retired" (Werner Dierks - age 90). The Board wishes to thank all of them for their service to our community.

The Board accomplished many projects during 2012. The new sign for the KD entrance looks great! This year, several trees were cut down in various locations throughout Kensington Downs. Since the annual meeting, all the stumps have been ground down and the resulting holes have been filled. Some projects from 2012 are ongoing, such as the repair and re-painting of the USPS mailboxes.

Highlighted projects for 2013 include: (1) landscaping changes at the front entrance; (2) planting trees to replace those damaged during the June windstorm; (3) distributing updated versions of the Homeowner Directory and KDCA Bylaws; (4) repainting the (wooden) street signs, and (5) installing ADA ramps on common area sidewalks.
